CERTIFICATE OF AMENDMENT TO THE DECLARATION OF COVENANTS AND RESTRICTIONS AND BYLAWS FOR INDIAN CREEK PHASE VIII HOMEOWNERS ASSOCIATION, INC.

WHEREAS, the Declaration of Covenants and Restrictions for Indian Creek Phase VIII Homeowners Association, Inc. was recorded in Official Records Book 5770, Page 1131, of the Public Records of Palm Beach County, Florida, and subsequently amended (hereinafter collectively referred to as the "Declaration"); and

WHEREAS, the Bylaws for Indian Creek Phase VIII Homeowners Association, Inc., were recorded in Official Records Book 5770, Page 1151, of the Public Records of Palm Beach County, Florida (hereinafter referred to as the "Bylaws"); and

WHERE the Articles of Incorporation for Indian Creek Phase VIII Homeowners Association, Inc., were recorded in Official Records Book 5770, Page 1163, of the Public Records of Palm Beach County, Florida (hereinafter referred to as the "Articles"); and

WHEREAS, the Declaration, Bylaws, and Articles provide for amendments, as set forth herein.

NOW THEREFORE; the Declaration and Bylaws are hereby amended as follows (additions to prior language are reflected by <u>underlining</u>, and deletions of prior language are <u>struck through</u>):

Amendments to the Declaration

Amendment #1

Article VIII, Section 1 of the Declaration of Covenants and Restrictions shall be revised, to read in its entirety as follows:

"1. <u>Architectural Control Committee</u>. The Architectural Control Committee (hereinafter referred to as "ACC") consisting of three (3) or more persons shall be appointed by the Board. <u>No person shall serve as a Director and a member of the ACC at the same time, unless there are not at least three (3) non-directors willing to serve on the ACC."</u>

Amendment #2

Article IV, Section 6 of the Declaration of Covenants and Restrictions shall be revised, to read in its entirety as follows:

"6. Pets. No animals shall be raised, bred, or kept on any Lot, except that dogs, cats, or other household pets may be kept on the Lot, provided they are not kept, bred or maintained for any commercial purpose, or in numbers deemed unreasonable by the Board. No owner may keep more than three (3) domestic pets on any Lot. Any owner who already has pets in excess of the above amount as of the recording date of this Amendment, shall

be grandfathered; however, upon the death or removal of any such grandfathered pet, the owner shall not replace such pet unless, after replacement, the owner would be in compliance with the number of allowed pets per this section. Notwithstanding the foregoing, no animal may be kept on the Lot which in the judgment of the Board results in a nuisance of sobnoxious or aggressive to the residents in the vicinity. Pets shall not be permitted away from any Lot unless under leash, nor may an Owner leave his pet on the patio of the home when the Owner is away from the Home. Each pet Owner shall be required to clean up after the pet in order to properly maintain the Lots or Common Areas. Each Lot Owner by acquiring a Lot agrees to indemnify the Association, and hold it harmless against any loss of lability resulting from his, his family member's or lessee's ownership of a pet. Owner is responsible for any and all damage caused by their pet(s) to the Common Areas or any other property owned or maintained by the Association or other Unit Owners. If a dog or any other animal becomes obnoxious or aggressive to other Owners by barking or otherwise the Owner shall remedy the problem or upon written notice from the Association, he will be required to permanently remove the pet from the Lot."

Amendment #3
Article IV, Section 5 of the Declaration of Covenants and Restrictions shall be revised, to read in its entirety as follows:

"5. Commercial Use. The single family homes shall not be used in any trade, business, professional or commercial capacity, except that the Home may be leased as a single family residence, and the Home may be used for a small, limited, home business but may not involve excessive deliveries, visits or parking by employees, customers or clients, or any other behavior or nuisance that creates an unreasonable impact on the residential neighborhood, in the discretion of the Board of Directors. Nothing contained herein shall prohibit Declarant from carrying on any and all types of construction activity necessary to accomplish the general plan of development, including the construction and operation of a sales model and office by the Declarant, until all of the Lots have been sold."

Amendment #4

Article XIII, Section 2 of the Declaration of Covenants and Restrictions shall be revised, to read in its entirety as follows:

"2. Owner's Consent. After the Amendment Date, this Declaration may be amended only by consent of fifty-one percent (51%) of all Owners together with the consent of the institutional mortgage with the highest aggregate mortgage indebtedness on the Lots. The aforementioned consent shall be obtained either by written consent or by a vote at a duly called meeting shall be in writing and affixed to the Amendment to this Declaration."

Amendments to the Bylaws

Amendment #5

Article IV, Section A.2. of the Bylaws shall be revised, to read in its entirety as follows:

"2. To provide for continuity of experience, beginning with the 2018 annual election, the Owners shall elect three (3) Directors for a term of two (2) years and four (4) Directors for a term of one (1) year. The candidates receiving the three (3) highest number of votes at the meeting shall be elected to the two (2) year term and the next four (4) candidates receiving the next highest number of votes shall be elected to a one (1) year term. Beginning with the 2019 annual election and thereafter, Directors shall be elected and serve for a term of two (2) years, provided that for so long as the Declarant is a Member it may elect not less than 1/3 of the Board. Directors shall hold office until their successors are elected and shall qualify (except as to the initial Board of Directors, whose members are designated in the Articles of Incorporation, and who shall serve pursuant to the terms of ARTICLE VIII of the Articles of Incorporation)."

Amendment #6

Article IV, Section A for the Bylaws shall be revised, to read in its entirety as follows:

"4. At the first each annual meeting of the Members after the Transfer date beginning with the 2019 electron, Directors shall be elected for a term of one two years."

Amendment #7

The first paragraph of Article IV, Section C. of the Bylaws shall be revised, to read in its entirety as follows:

"C. RESIGNATION AND VĂÇĂNCY

Any Director or Officer of the Corporation may resign at any time by a written instrument delivered to the President (or to the Secretary if the President resigns) or by action evidencing an intent to resign. Resignations effectuated by a written instrument shall take effect at the time specified therein, and if no time is specified, at the time of receipt by the President or Secretary of the Corporation. Resignations effectuated by an "action evidencing an intent to resign" shall take effect at the time such action comes to the attention of the President or the Secretary of the Corporation and is confirmed in writing by the President or Secretary. The acceptance of a resignation shall not be necessary to make it effective. Any Director or Officer who has missed three (3) Board meetings in a twelve (12) month period may be removed from the Board by a majority vote of the remaining Board Members. Any Board Member who has resigned without good cause or been removed by the Board is ineligible to run for the Board for three (3) years after leaving the Board."

Amendment #8

Article VI, Section A. (5) of the Bylaws shall be revised, to read in its entirety as follows:

o "A. The President shall:

Appoint committees including but not limited to an architectural control committee, and to be ex-officer member of all committees, and render an annual report at the annual meeting of Members.

Except as otherwise expressly set forth herein, the terms and conditions of the Declaration and Bylaws as previously amended, are hereby reaffirmed.

It is hereby certified that the foregoing Amendments to the Declaration for Indian Creek Phase VIII Homeowners Association, Inc., were approved by the written consent of fifty-one (51%) all Members, pursuant to Article XIII of the Declaration, and that the foregoing Amendments to the Bylaws were approved by a majority of the Board of Directors and a majority of the Members casting a vote by written consent as if they were present at a meeting at which a quorum was present, pursuant to Article XIV of the Bylaws and Article XI of the Articles of Incorporation.
