TREASURER'S REPORT FOR PERIOD ENDING SEPTEMBER 30, 2025

CASH:

Operating cash totals \$105,392.34. \$1,478.65 is October payables, and \$31,705.32 is prepaid maintenance fees. The net operating cash is \$72,208.37.

Reserve cash totals \$120,958.05. YTD reserve expenditures include \$12,570 from Paint/Sealcoat. YTD reserve interest is \$2,401.88, and \$30,000 was transferred to Reserve-Clubhouse/Pool Deck from Reserve Interest and Fund Surplus in January.

CURRENT YEAR END EXPENSES ARE AS FOLLOWS FOR THE ASSOCIATION:

Administrative Expenses: Current month total is \$4,514.48, YTD is \$45,289.89, which is \$2,597.67 under budget.

Utility Expenses: Current month total is \$17,098.86, YTD is \$153,321.20, which is \$1,028.80 under budget.

Grounds: Current month total is \$8,475.64, YTD is \$74,711.32, which is \$16,434.65 under budget.

Pool & Recreation: Current month total is \$1,747.60, YTD is \$15,287.02, which is \$2,311.99 over budget.

CURRENT YEAR TO DATE SURPLUS/DEFICIT:

YTD revenue is \$326,791.44, operating expenses are \$288,609.43, and the reserves have been funded \$20,803.23. The current year-to-date surplus is \$17,378.78.

FUND BALANCE:

As of 1/1/25 the beginning fund balance was a surplus of \$63,623.85. The current year-to-date surplus is \$17,378.78, and \$27,000 was transferred to Reserves-Clubhouse. There is also \$22,512.44 in Capital Contributions. The total adjusted fund balance is \$76,515.07.

ACCOUNTS RECEIVABLE:

As of 9/30/2025, the total in arrears is \$1,429.05.
